One 07-27-05 at 1500 hrs the defendant was driving in the 5200 blk. of 14th St. west. The defendant stopped at the Shell station for gas. A blue vehicle pulled up to the defendant's vehicle and the driver got out. The driver walked up to the defendant's vehicle and as he did the defendant rolled down his window, pointed a pistol out the window and shot twice in the direction of the man walking towards his vehicle. One bullet struck the victim in the abdomen and the other struck a vehicle parked behind the defendant. The defendant fled the area. A bolo was issued for the defendant's vehicle. The defendants vehicle was observed by a MCSO deputy and a traffic stop was made in the 300 blk of 60th Ave. e. Witnesses at the Shell station were brought to the traffic stop and the defendant was positively identified as the person who shot the victim. Also passengers in the vehicle identified the defendant as the same person who shot the victim.
